> Article 1 **OBJECTIVE OF COOPERATION**

- 8. Undertaking Joint Research Programmes where possible.
- 9. Publication of Books containing Academic Papers/ Research Articles and / or special issues with ISBN.
- 10. Academic and Administrative Audit (AAA).
- 11. Any other academic and Administrative Activities.

#### Article 3 FINANCIAL ARRANGEMENT

Any cooperation under this MOU is subject to the availability of funding sources and approval of relevant authorities.

#### Article 4 LOCATION OF ACTIVITIES

The parties agree to implement the programmes stated in Article 2 at Ananda Mohan College, Kolkata and Women's College, Calcutta.

Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

#### Article 5 MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted both on Online/ Offline mode. Ample arrangements should also be made to conduct programmes in the Blended mode if required.

1) This MOU may be amended or revised at any time by mutual written consent of the parties and such amendment shall form an integral part of this MOU.

2) Such amendment /s o revision/s shall come into force on the date as may be determined by the Parties.

## Article 8 SETTLEMENT OF DISPUTES

Any dispute concerning the interpretation and/ or application of this MOU shall be settled amicably through consultations or negotiations between the Parties.
